8.4 Approve 2024-25 Annual Organizational Meeting Date Selection

The annual organizational meeting of the governing board will be Friday, December 13, 2024 at 6:00 pm.

Per California Education Code Section 35143, the Governing Board of a school district must hold its 2024 Annual Organizational Meeting between December 13, 2024 and December 27, 2024.

First Interim must be approved by the Board within 45 days of October 31. It is due December 15.

The only way to meet these two requirements and hold one board meeting in December, this

meeting must be held on either Friday, Saturday, or Sunday.

8.5 Approve MOU between GTFE and GTUSD regarding Lesson Plans

While normally lesson plans are the responsibility of the Teacher of Record (TOR), should the situation arise where there is no TOR or the TOR lacks sufficient expertise, and the Corresponding Teacher in the same department agrees, this collective bargaining agreement allows for a stipend to be paid to the teacher who prepares the lesson plans.

8.6 Approve Letter of Agency to Participate in CENIC E-rate Consortium

The Letter of Agency gives California K-12 High Speed Network and Corporation for Education Network Initiatives in California (CENIC) the ability to seek E-rate discounts on the statewide circuits. The E-rate discounts that CENIC applies for are different than any circuits or other telecommunications services that LEA's contract for separately, and therefore, no overlap or conflict is created between the CENIC E-rate application and the applications of individual LEA's.

GTUSD would like to join other California LEAs in the statewide consortium led by CENIC. There is no fee to join the consortium, and GTUSD participation will directly contribute to maximizing the E-rate subsidies that support the statewide network and thus leveraging the state's investment and benefiting all LEAs.

To join the CENIC E-rate Consortium, GTUSD must execute the Letter of Agency.
